

## **Mister Potato Snack to Win Terms and Conditions:**

The following terms and conditions (the “Terms and Conditions”) shall apply to the ‘Snack to Win’ lucky draw (the “contest”).

### **1. Eligibility**

- 1.1. This contest is open only to residents and permanent residents of Singapore eighteen (18) years old and above.
- 1.2. Employees of Field Catering and Supplies Pte Ltd. (the “Organiser”), their immediate family members, its advertising agencies, and any other parties directly involved in organising, promoting, or conducting the Contest is not eligible to participate in the Contest.

### **2. Contest Period**

- 2.1. The Contest is open from 1 October 2017 to 30 Nov 2017, both dates inclusive (the “Contest Period”).

### **3. Participation in the Contest**

- 3.1. The participant will be entitled to one (1) lucky draw entry for every purchase of two (2) canisters of Mister Potato Crisps (130g) in a single receipt.
- 3.2. Only purchases made during the Contest period will be accepted.
- 3.3. Each participant may enter multiple times. However, only the entries per single receipt will be accepted. Cumulative receipts are not allowed. No repeated/multiple entries for the same receipt will be accepted for the Lucky Draw. Participants are required to keep the receipt as proof of purchase.
- 3.4. The Organiser is not responsible for inaccurate details supplied by any participant.
- 3.5. The Organiser reserves the right to disqualify all entries that do not meet the rules and regulations of the Contest. These include entries submitted with invalid or incorrect information.

### **4. Conduct of Lucky Draw and Prizes**

- 4.1. The lucky draw will be conducted at Field Catering and Supplies Pte Ltd, 28 Senoko South Road, Singapore 758090 on 11 December 2017.
- 4.2. There will be one (1) Grand Prize winner of the Nintendo Switch game console.
  - 4.2.1. The prize includes one (1) Nintendo Switch game console and two (2) Nintendo Switch games (Just Dance 17 + Legend of Zelda).
  - 4.2.2. The total value of the Grand Prize is \$699.00

4.2.3. The first valid entry drawn will win the Grand Prize. If the winner does not claim the Grand Prize within 14 days of the Organiser having notified the winner in accordance with clause 5.1, the Grand Prize is deemed unclaimed and the prize will automatically fall to the next-in-line winner. This procedure will be repeated until a winner is found. If no winner is found after this procedure has been repeated 10 times, the Grand Prize will be donated to a charity of the Organiser's choice.

4.3. There will be one (1) 2<sup>nd</sup> Prize winner of the Fujifilm instax SQUARE SQ10 Hybrid Instant Camera

4.3.1. The prize includes one (1) Fujifilm instax SQUARE SQ10 and one (1) Fujifilm instax Square instant film

4.3.2. The total value of the Grand Prize is \$499.00

4.3.3. The first non-repetitive entry drawn will win the 2<sup>nd</sup> Prize. If the winner does not claim the 2<sup>nd</sup> Prize within 14 days of the Organiser having notified the winner in accordance with clause 5.1, the 2<sup>nd</sup> Prize is deemed unclaimed and the prize will automatically fall to the next-in-line winner. This procedure will be repeated until a winner is found. If no winner is found after this procedure has been repeated 10 times, the 2<sup>nd</sup> Prize will be donated to a charity of the Organiser's choice.

4.4. There will be five (5) 3<sup>rd</sup> Prize winners picked during the Lucky Draw. Each 3<sup>rd</sup> prize winner will win \$200 Courts shopping vouchers.

4.4.1. The total value of the 3<sup>rd</sup> Prize is \$1,000.

4.4.2. The first non-repetitive five entries drawn will win the 3<sup>rd</sup> prize. If the winner does not claim the 3<sup>rd</sup> Prize within 14 days of the Organiser having notified the winner in accordance with clause 5.1, the 3<sup>rd</sup> Prize is deemed unclaimed and the prize will automatically fall to the next-in-line winner. This procedure will be repeated until a winner is found. If no winner is found after this procedure has been repeated 10 times in total, the 3<sup>rd</sup> Prize will be donated to a charity of the Organiser's choice.

4.5. All prizes are non-transferable and non-convertible to cash. Prizes are subject to availability and the Organiser reserves the right to substitute any prize with another of equivalent value without prior notice.

4.6. Each winner is entitled to win one prize, regardless of how many times their lucky draw entries are picked. In the event a winner's lucky draw entry is picked for more than one time, the Organiser shall be entitled to disregard the second and subsequent picks and re-pick a winner.

## **5. Winner Notification and Prize Collection**

5.1. The Organiser shall contact the Winners via phone/email within seven (7) days of the conduct of the Lucky Draw ("Notification"). Only shortlisted participants will be contacted.

5.2. The winners of the Contest are required to submit in person or through a validly authorised representative the following documents to the Organiser's prize fulfilment centre at 28 Senoko South, Singapore 758090 within seven working days of having been notified that he/she has won the Contest:

- the original receipt
- a clear legible copy of his/her NRIC

5.3. The Organiser reserves the right, in its sole discretion, to reject a Prize winner if he/she is unable to satisfy the conditions set out in 5.3.

## **6. Use of Personal Information**

6.1. By participating in this Contest, the participant understands and accepts that the Organiser and its agencies, affiliates, and any other parties directly involved in organising the Contest, may collect, use and disclose the participant's personal data, for the following purposes in accordance with the Personal Data Protection Act 2012:

6.1.1. To administer this Contest, including contacting the winners for the administration of prizes in relation to this Contest.

## **7. General**

7.1. By participating in the Contest, the Participant is deemed to have accepted and agreed to be bound by these Terms and Conditions and any other instructions, terms and conditions that the Organiser may issue from time to time.

7.2. The Organiser shall not be liable to any persons in the Contest for any injuries, losses or damages in respect of, in connection with and/or arising from the Contest.

7.3. The Organiser reserves the right to video, photograph and/or record the Contest, and publish any participants' images and details for the purposes relating to the publicity of the Contest without having to pay any fee or compensation to the Participants.

7.4. The Organiser reserves the right to withdraw or cancel the Contest and to amend or change these Terms and Conditions at any time for whatever reason and without giving prior notice to the Participants. The decision of the Organiser on all matters relating to or in connection with the Contest is final, and no correspondence will be entertained.

7.5. A Participant shall fully indemnify and hold the Organiser harmless from and against any loss, damage, cost, liability or expense (including legal fees), whether direct or indirect, which the Organiser incurs in respect of, in connection with and/or arising from the Participant's breach of these Terms and Conditions.

7.6. In the event of any inconsistencies or discrepancies between the Terms and Conditions and the contents of any brochure, marketing and/or promotional materials relating to the Contest, these Terms and Conditions shall prevail.

7.7. The Contest Terms and Conditions shall be governed by and interpreted in accordance with Singapore law. The Courts of Singapore shall have exclusive jurisdiction over any disputes arising from these Terms and Conditions, including the validity and enforceability thereof.
